Agencies and Nodal Ministries Involved in Swachh Bharat Abhiyan

The **Swachh Bharat Abhiyan (SBA)** was launched on **2nd October 2014** by the Government of India to achieve universal sanitation coverage and to make India clean and open defecation free (ODF).

It has two main sub-missions, each handled by separate ministries.

1. Ministry of Housing and Urban Affairs (MoHUA)

(For Urban Areas – Swachh Bharat Mission–Urban, SBM-U)

Functions & Responsibilities:

- Implementation of sanitation and waste management programs in **urban areas**, towns, and cities.
- Construction of **individual and community toilets** in urban households.
- Development of **Solid Waste Management systems** (collection, segregation, transportation, and disposal).
- Promoting behavioral change and public participation through campaigns.
- Conducting **Swachh Survekshan** (Cleanliness Survey) to rank cities based on cleanliness.
- Coordinating with Urban Local Bodies (ULBs) for effective execution.

2. Ministry of Jal Shakti (Department of Drinking Water and Sanitation – DDWS)

(For Rural Areas – Swachh Bharat Mission–Gramin, SBM-G)

Functions & Responsibilities:

- Ensuring Open Defecation Free (ODF) status in rural India.
- Construction of household latrines, community toilets, and solid & liquid waste management systems in villages.
- Promoting behavioral change and hygiene education among rural communities.
- Providing **financial and technical support** to States and Panchayati Raj Institutions.
- Monitoring through Swachh Bharat Mission Management Information System (MIS).

3. NITI Aayog

(Policy Guidance and Coordination)

- Provides strategic policy direction, coordination among ministries, and monitoring of outcomes.
- Assesses and recommends measures for better performance and sustainability of sanitation initiatives.

4. Ministry of Information and Broadcasting (MIB)

(Awareness and Communication Support)

- Conducts mass media campaigns like "Darwaza Band", "Har Ghar Shauchalaya", etc.
- Uses television, radio, and print media for spreading awareness about cleanliness and hygiene.

5. Ministry of Education (formerly MHRD)

(School Sanitation and Hygiene Education)

- Ensures that every school has **toilets and handwashing facilities** under the **Swachh** Vidyalaya Abhiyan.
- Promotes hygiene education and inclusion of cleanliness in the school curriculum.

6. Ministry of Health and Family Welfare (MoHFW)

(Public Health and Sanitation Linkages)

- Focuses on the health impact of poor sanitation.
- Coordinates activities linking sanitation, hygiene, and disease prevention programs.

7. Ministry of Environment, Forest and Climate Change (MoEFCC)

(Environmental Management)

- Oversees proper waste management and its impact on the environment.
- Promotes **eco-friendly practices**, recycling, and reduction of pollution.

8. Local Governments and Panchayati Raj Institutions

(Implementation at the Grassroot Level)

- Play a vital role in **mobilizing community participation**.
- Responsible for **construction**, **maintenance**, **and monitoring** of sanitation infrastructure at local levels.
